COMMITMENT TO SUCCESS

All Clients are responsible to follow-up with training and maintain the level of obedience established through suggested training by The Dog Haus. Results are directly related to the commitment of the Client to practice and apply advice. We at *The Dog Haus*, are committed to establishing good patterns and correcting negative behavior. Failure by the Client to continue training will lead to a reversal of patterning and reduced success. At any point, The Dog Haus reserves the right to withdraw from further training in the event that clients do not take training procedures seriously or misuse provided techniques.

EQUIPMENT

The Client agrees to the use of suitable training aids suggested for their dog which assists in the correction of behavioural issues. Clients need to apply common sense when using any equipment and are responsible for all injuries and/or damages which may occur.

Purchases of training services are non-transferable and must be used within four months of purchase.

CANCELLATIONS AND MAKE-UPS. All cancellations for private lessons must be made 24 hours in advance. If we do not receive 24 hour notice, you will be charged the full rate. Please note there are no makeup classes for training group lessons.
